What's new?

Hiscox has launched a new way of purchasing event insurance for small to mediumsized events taking place in the UK and exhibitors attending events anywhere in the EU. We're offering pre-packaged cancellation and abandonment, liability and property covers at a fixed price.

Events come in all shapes and sizes, so this isn't designed to replace bespoke underwriting for unusual events or for large events. That's still part of our offer, but we will apply a minimum premium of £400 plus IPT.

How does it work

Our pre-priced options are designed for the most common types of small to mediumsized events. Simply choose the right form for your client's event, select the cover they want and provided they meet the criteria set out in the form cover will start when we email you the policy.

There are two forms to choose from for event organisers, plus one for exhibitors:

Commercial and charity events

Cover for conferences, exhibitions, trade fairs, awards ceremonies and dinners with a budget of up to £100k, and/or up to 2,500 attendees.

Organisers of similar events will also be able to use this form, and we will advise if we can offer cover at the prices shown.

Coverage options include:

- up to £100k cancellation and abandonment cover, with an option to include profit and reduced attendance cover
- up to £5m public liability cover
- up to £10m employers' liability cover
- up to £25k general property cover (including £10k cover for damage to venue fixtures and fittings)
- up to £15k cover for computers, audio visual equipment and cameras.

Terrorism cover can be added to both the cancellation and property sections of cover.

You can also request a quote for $\mathfrak{L}10m$ limit public liability and high value property using this form.

Community, entertainment and sports events

Cover for events with up to 5,000 attendees:

- fêtes, fairs, fun days and street parties
- motoring events (static display)

- agricultural, country and horticultural shows
- classical, folk, blues and jazz music events
- sporting events (cricket, golf, rugby, badminton, hockey, snooker, swimming, tennis)
- literary, art, food and drink festivals
- theatre/drama events.

Organisers of similar events will also be able to use this form, and we will advise if we can offer cover at the prices shown.

Coverage options include:

- up to £5m public liability cover
- up to £10m employers' liability cover.

You can also request a quote for £10m limit public liability limit using this form.

We can also provide cancellation and property cover for this type of event, but it requires bespoke underwriting using a Hiscox Special Events proposal form (available from www.hiscoxbroker.co.uk/events) and we will apply a £400 minimum premium plus IPT.

Exhibitors

Exhibitors can choose from a number of simple options:

- public liability only a £1m or £2m limit
- a package of £2m public liability, up to £15k cancellation expenses and up to £15k property cover (including £10k cover for hired property)
- you can add employers' liability cover to your chosen option.
