for this section**

<b>Advertising</b>	Advertising, publicity, or promotion in or of <b>your</b> products or services, including social media and online.
<b>Applicable courts</b>	The courts of competent jurisdiction in those countries stated as the applicable courts in the schedule.
<b>Business activity</b>	The activities stated in the schedule, which <b>you</b> perform in the course of <b>your business</b> .
<b>Claim</b>	Any written assertion of liability or any written demand for financial compensation or injunctive relief first made against <b>you</b> within the <b>applicable courts</b> .
<b>Client</b>	Any person or entity with whom <b>you</b> have contracted to provide services or deliverables that expressly fall within <b>your business activity</b> .
<b>Defence costs</b>	All reasonable and necessary lawyers' and experts' fees and legal costs incurred with <b>our</b> prior written agreement in investigating, settling, defending, appealing or defending an appeal against a covered <b>claim</b> but not including any overhead costs, general business expenses, salaries, or wages incurred by <b>you</b> or any other person or entity entitled to coverage under this section.
<b>Employee</b>	An individual performing employment duties solely on <b>your</b> behalf in the ordinary course of <b>your business activity</b> and who is subject to <b>your</b> sole control and direction and to whom <b>you</b> supply the instruments and place of work necessary to perform such <b>business activity</b> . <b>You</b> and <b>your</b> sub-contractors or self-employed freelancers will not be treated as <b>employees</b> under this section.
<b>Loss</b>	Any financial harm caused to <b>your business</b> .
<b>Personal data</b>	<ol style="list-style-type: none"><li>1. Any data relating to a living individual who can be identified from that data; or</li><li>2. any sensitive personal data as defined in the Data Protection Act 1998 or any similar or successor legislation.</li></ol>
<b>Pollution</b>	Any pollution or contamination, including noise, electromagnetic fields, radiation and radio waves.
<b>Potential claim</b>	Anything likely to lead to a <b>claim</b> covered under this section.
<b>Retroactive date</b>	The date shown as the retroactive date in the schedule. For any <b>subsidiary</b> acquired by <b>you</b> during the <b>period of insurance</b> the retroactive date will be the date of acquisition.
<b>Subsidiary</b>	An entity domiciled in the United Kingdom of Great Britain and Northern Ireland, the Channel Islands, the Isle of Man or Gibraltar: <ol style="list-style-type: none"><li>1. that has been identified in <b>your</b> proposal for this <b>policy</b> and of which <b>you</b> own more than 50% of the book value of the assets or of the outstanding voting rights as of the first day of the <b>period of insurance</b>; or</li><li>2. which <b>you</b> acquire during the <b>period of insurance</b> where the turnover at the date of acquisition is less than 20% of <b>your</b> turnover and the acquired entity's <b>business activity</b> is the same as <b>yours</b>.</li></ol>

## What is covered

<b>Claims against you</b>	If during the <b>period of insurance</b> , and as a result of <b>your business activity</b> or <b>advertising</b> on or after the <b>retroactive date</b> within the <b>geographical limits</b> , any party brings a <b>claim</b> against <b>you</b> for any actual or alleged:
Breach of contract	1. breach of any contract, including the APA contract for the Production of Commercials, between <b>you</b> and <b>your client</b> . However, this only applies where the <b>claim</b> is brought by <b>your client</b> ;
Intellectual property infringement	2. intellectual property infringement (but not any patent infringement or trade secret misappropriation), including but not limited to: <ol style="list-style-type: none"> <li>a. infringement of copyright, trademark, trademark dilution, trade dress, publicity rights, moral rights or design rights;</li> <li>b. cyber-squatting violations;</li> <li>c. any act of passing-off;</li> <li>d. misappropriation of formats, characters, trade names, character names, titles, plots, musical compositions, voices, slogans, graphic material or artwork;</li> </ol>
Negligence	3. negligence or breach of any duty to use reasonable care and skill, including but not limited to negligent misrepresentation or negligent loss of or damage to any third-party document, data or information for which <b>you</b> are responsible;
Breach of confidentiality	4. breach of any duty of confidence, invasion of privacy, or violation of any other legal protections for personal information.
Defamation	5. defamation, including but not limited to libel, slander, trade libel, product disparagement, or malicious falsehood, or any <b>claim</b> for emotional distress or outrage based on harm to the character or reputation of any person or entity;

Breach of advertising codes	9. unintentional breach of the CAP, BCAP or ASA codes, consumer protection regulations or other legislation related to advertising, where the <b>claim</b> is brought by <b>your client</b> ;
Civil liability	10. any other civil liability;
	unless excluded under <b>What is not covered</b> below, <b>we</b> will pay the amount agreed by <b>you</b> and <b>us</b> through good faith negotiation, mediation or some other form of alternative dispute resolution to settle a <b>claim</b> or the amount to satisfy a judgment or arbitration award against <b>you</b> including any judgment or award ordering the payment of claimant's lawyers fees and costs.
	<b>We</b> will also pay <b>defence costs</b> , but <b>we</b> will not pay costs for any part of a <b>claim</b> not covered by this section.
Sub-contractors or self-employed freelancers	<b>We</b> will indemnify <b>you</b> against any <b>claim</b> falling within the scope of <b>What is covered</b> , Claims against you, which is brought as a result of <b>business activity</b> undertaken on <b>your</b> behalf by any sub-contractor or self-employed freelancer.

	<ol style="list-style-type: none"><li>denial of service attack against a third-party;</li><li>unauthorised acquisition, access, use, or disclosure of <b>personal data</b> or confidential corporate information that is held or transmitted in any form; or</li><li>prevention of authorised electronic access to any computer system, <b>personal data</b> or confidential corporate information.</li></ol>
Payments toward your outstanding fees	<p>If:</p> <ol style="list-style-type: none"><li><b>your client</b> has reasonable grounds for being dissatisfied with the work <b>you</b> have done or which has been done on <b>your</b> behalf and refuses to pay for any or all of it, including amounts <b>you</b> legally owe to sub-contractors or self-employed freelancers at the date of the refusal;</li><li><b>your client</b> threatens to bring a <b>claim</b> against <b>you</b> for more than the amount owed; and</li><li><b>we</b> believe that it may be possible to settle the dispute with the <b>client</b> by <b>your</b> agreeing not to press for the disputed amount,</li></ol> <p><b>we</b> may pay <b>you</b> the amount owed to <b>you</b> over and above the <b>excess</b>. If <b>we</b> do, <b>you</b> must agree not to press <b>your client</b> for the disputed amount.</p> <p>Alternatively, if it is not possible to reach agreement with the <b>client</b> on this basis but <b>we</b> still believe that by not pressing for the disputed amount <b>you</b> will avoid a legitimate <b>claim</b> or counterclaim for a greater amount, <b>we</b> may pay the amount owed to <b>you</b> at that time, over and above the <b>excess</b>.</p> <p>If a <b>claim</b> is still brought, <b>we</b> will deal with it but <b>our</b> total payment, including what <b>we</b> have already paid <b>you</b> or on <b>your</b> behalf, will not exceed the applicable limit of indemnity in the schedule. <b>You</b> must return the amount <b>we</b> have paid if <b>you</b> eventually recover the debt, less <b>your</b> reasonable expenses.</p> <p>Once <b>we</b> agree to make any payment above, <b>you</b> will assign to <b>us</b> such rights as <b>you</b> have in relation to the amounts owed to <b>you</b>.</p> <p><b>We</b> will not make any payment for any money owed to <b>you</b> if the <b>claim</b> or threatened <b>claim</b>, or part of the <b>claim</b> or threatened <b>claim</b>, is not covered by this section.</p>
<b>Your own losses</b>	
Losses from dishonesty	<p>If during the <b>period of insurance</b>, and in the performance of <b>your business activity</b> within the <b>geographical limits</b>, <b>you</b> discover a loss from the dishonesty of <b>your employees</b>, sub-contractors or self-employed freelancers directly contracted to <b>you</b> and under <b>your</b> supervision, where there was a clear intention to cause <b>you</b> loss or damage and to obtain a personal financial gain over and above any salary, bonus or commission, <b>we</b> will indemnify <b>you</b> against <b>your</b> direct financial loss, provided the loss was suffered on or after the <b>retroactive date</b>.</p>
Loss of documents	<p>If during the <b>period of insurance</b> any document, information or data of <b>yours</b> which is necessary for the performance of <b>your business activity</b> is lost, damaged or destroyed while in <b>your</b> possession, <b>we</b> will pay the reasonable expenses <b>you</b> incur with <b>our</b> prior written agreement in restoring or replacing it. The most <b>we</b> will pay for the total of all such expenses is the relevant amount in the schedule.</p>
Acting outside your authority	<p>If a <b>client</b> refuses to pay for media space that <b>you</b> are legally committed to pay for in the performance of <b>your business activity</b>, <b>we</b> will pay the amount <b>you</b> are committed to pay which <b>you</b> satisfy <b>us</b> cannot legally be recovered from <b>your client</b>. <b>We</b> will only do this provided:</p> <ol style="list-style-type: none"><li>the <b>client</b> is not liable to <b>you</b>;</li><li><b>you</b> made this commitment in good faith in the belief that <b>you</b> had <b>your client's</b> authority to do so; and</li><li><b>you</b> have taken all reasonable steps to reduce <b>your loss</b>.</li></ol>
Payments toward your rectification costs	<p>If <b>you</b> become aware of a <b>potential claim</b> with or without your <b>client's</b> knowledge, which directly arises from an act, error or omission occurring during the course of <b>your business activity</b>, then <b>we</b> will pay any reasonable and necessary costs exceeding the amount of the <b>excess</b> that <b>you</b> incur during the <b>period of insurance</b> (excluding <b>your</b> lost profits, management costs, mark-up, liability for taxes, or any measure of lost business) to rectify that error provided <b>you</b>:</p>

- a. notify **us** of the error as soon as practicable;
- b. satisfy **us** that a future **claim** would likely result from that error if not rectified;
- c. satisfy **us** that such future **claim** would likely be covered under this **policy** and involve a demand for damages greater than the cost of rectifying the error; and
- d. obtain **our** prior written agreement before incurring such rectification costs, or incur such costs within ten days of first learning of the error and later provide **us** with all information and documentation that **we** require to support the rectification costs **you** have incurred and the actions **you** have taken.

If subsequently a **claim** is still made against **you** following **our** payment of these rectification costs then these payments will be deducted from the amount **we** will pay toward resolution of that **claim** as well as the remaining limit of indemnity available for that **claim**.

## Additional cover

Court attendance compensation

If any person within the definition of **you**, or any **employee** of **yours**, has to attend court as a witness in connection with a **claim** against **you** covered under this section, **we** will pay **you** the amount shown in the schedule as compensation for each day or part of a day that their attendance is required by **us**. The most **we** will pay for the total of all court attendances is the amount shown in the schedule.

## What is not covered

Insufficient resources	A. <b>We</b> will not make any payment for any <b>claim</b> or <b>loss</b> or part of any <b>claim</b> or <b>loss</b> directly or indirectly due to:
Injury	1. <b>your</b> failure to take all reasonable steps to ensure that <b>you</b> have sufficient technical, logistical and financial resources to perform a contract.
Property damage	2. any death of or any bodily or mental injury or disease suffered or alleged to be suffered by anyone. However, this exclusion does not apply to any <b>claim</b> seeking damages for mental anguish or distress, where such damages solely stem from a covered <b>claim</b> for defamation, breach of privacy, or negligent publication or negligent broadcast.
Government investigation/enforcement	3. loss, damage or destruction or loss of use of any tangible property. However this exclusion does not apply to any: <ol style="list-style-type: none"> <li>a. <b>claim</b> for alleging or arising from damage to electronic data;</li> <li>b. <b>loss</b> directly arising from any document of <b>yours</b> which is necessary for the performance of <b>your business activity</b> and which is lost, damaged or destroyed while in <b>your</b> possession.</li> </ol>

Product design	25. from any liability for any product design, industrial design, architectural design, or architectural services.
Redemption level estimates	26. any: <ul style="list-style-type: none"> <li>a. prize, coupon, or voucher redemption level estimates or forecasts being exceeded or not met; or</li> <li>b. over redemption or under redemption of coupons, discounts, awards or prizes from advertisements, promotions, contests or other games of chance;</li> </ul> unless <b>we</b> have specifically agreed to cover this by an <b>endorsement</b> to this <b>policy</b> .

Payment owed under licence	29. from any payment owed to a licensor under a licence; however, this exclusion will not apply to any covered portion of any copyright and/or trademark <b>claim</b> that results in a damage award that is measured by the amount a claimant would have received had <b>you</b> paid for a licence to use the claimant's infringed work and/or mark.
Property owners liability	30. for, alleging, or arising from property owners' liability.  B. <b>We</b> will not make any payment for:
Claims brought by a related party	1. any <b>claim</b> brought by any person or entity falling within the definition of <b>you</b> or any party with a financial, executive or managerial interest in <b>you</b> , including any parent company or any party in which <b>you</b> have a financial, executive or managerial interest, including any subsidiary company.  However, this does not apply to a <b>claim</b> based on a liability to an independent third-party directly arising out of the performance of <b>your business activity</b> .
Claims by current and former employees	2. any <b>claim</b> made against <b>you</b> by any person or entity that <b>you</b> currently employ or formerly employed, including but not limited to <b>employees</b> , sub-contractors or self-employed freelancers.  However, this exclusion will not apply to any part of any <b>claim</b> : <ul style="list-style-type: none"> <li>a. solely based on <b>business activity</b> performed when such person or entity was not working for <b>you</b>;</li> <li>b. based on a liability to an independent third-party directly arising out of the performance of <b>your business activity</b>.</li> </ul> However, this exclusion shall not apply to any otherwise covered <b>claim</b> from an <b>employee</b> , subcontractor or self-employed freelancer that is brought entirely independently of that party's position as <b>your employee</b> , subcontractor or self-employed freelancer.
Non-compensatory payments	3. punitive or exemplary damages, which <b>you</b> are legally obliged to pay. However <b>we</b> will pay an award of such damages if insurable in the jurisdiction where such award was first ordered.
Fines and penalties	4. criminal, civil, or regulatory sanctions, fines, penalties, disgorgement of profits, treble damages or multiple damages which <b>you</b> are legally obliged to pay, including but not limited to those imposed by any national, local, federal, state or foreign governmental

body or by the Mechanical Copyright Protection Society (MCPS)-Performing Rights Society (PRS) Alliance, American Society of Composers Authors and Publishers (ASCAP), Broadcast Music Inc. (BMI), Society of European Stage Authors and Composers (SESAC), or any other similar licensing organisation.

Claims outside the applicable courts

5. any **claim**, including arbitration, brought outside the **applicable courts**.

This applies to proceedings in the **applicable courts** to enforce, or which are based on, a judgment or award from outside the **applicable courts**.

Trading losses

6. any trading loss or trading liability including those arising from the loss of any **client**, account or business.

## Special condition

Takeovers and mergers extended notification period

In the event that **you** merge or consolidate with another company, or any party acquires more than 50% of **your** issued share capital, during the **period of insurance you** may on payment of an additional premium of 150% of the annual premium request that this section continue in force for a period of 24 months from the expiry date of the current **period of insurance**. Such extension shall only apply to **claims** arising from **business activity** prior to the date of such takeover or merger.

## How much we will pay

The most **we** will pay for the total of all **claims**, their **defence costs**, and **losses** is the overall limit of indemnity stated in the schedule, irrespective of the number of **claims** or **losses**, unless limited below or in the schedule. **You** must pay the relevant **excess** stated in the schedule.

Any amounts to be paid by **us** shall not include or be calculated based on any of **your** overhead expenses, **your** liability for debt, taxes, lost costs or profits, salaries or wages, or any future cost of doing business, including but not limited to the cost of any future licence or royalty, or costs of improving **your** security, or performing audits.

**You** must pay the relevant **excess** stated in the schedule. The **excess** will only be eroded by the covered part of the **claim**.

When **we** settle a loss under **Your own losses**, Losses from dishonesty, **we** will deduct any sums **you** owe or the value of any property **you** hold belonging to the perpetrator.

## Special limits

Losses from dishonesty

The most **we** will pay for the total of **your** own losses arising from the dishonesty of **your employees**, sub-contractors and self-employed freelancers is the relevant amount stated in the schedule.

**You** must pay the relevant **excess** stated in the schedule.

Paying out the limit of indemnity

At any stage of a **claim we** can pay **you** the applicable limit of indemnity or what remains after any earlier payment from that limit. **We** will pay **defence costs** already incurred at the date of **our** payment. **We** will then have no further liability for that **claim** or its **defence costs**.

## Your obligations

If a problem arises

1. **We** will not make any payment under this section unless **you** notify **us** of:
  - a. any **claim** made against **you** or any **loss** as soon as practicable and within the **period of insurance** or at the latest within 14 days after the **policy** expires for any **claim** or **loss you** first became aware of in the seven days before expiry;
  - b. **potential claims** under this section, such notification must be as soon as practicable and within the **period of insurance** or at the latest within 14 days after the **policy** expires, and must to the fullest extent possible identify the particulars of the **potential claim**, including identifying any potential claimant, the likely basis for liability, the likely demand for relief and any additional information about the **potential claim** that **we** reasonably request. If such a **potential claim** notification is made to **us** then **we** will treat any **claim** arising from the same particulars as that notification as if it had first been made against **you** on the date **you** properly notified

- us** of it as a **potential claim**, even if that **claim** is first made against **you** after the **period of insurance** has expired;
- c. **your** discovery, or the existence of reasonable grounds for **your** suspicion, that any **employee** or sub-contractor or self-employed freelancer has acted dishonestly, as soon as reasonably practicable.
2. **You** must:
- a. ensure that **our** rights of recovery, including but not limited to any subrogated rights of recovery, against a third-party are not unduly restricted or financially limited by any term in any of **your** contracts;
  - b. not admit that **you** are liable for what has happened or make any offer, deal or payment, unless **you** have **our** prior written agreement.
- If **you** fail to comply with these obligations, **we** may reduce any payment **we** make under this section by an amount equal to the detriment **we** have suffered as a result.

## Control of defence

<b>Defence arrangements</b>	This is a duty to defend section. This means that <b>we</b> have the right and duty to defend <b>you</b> against any <b>claim</b> which is covered in its entirety.
Appointment of legal representation	If <b>we</b> think it necessary <b>we</b> will appoint an adjuster, solicitor or any other appropriate person to deal with the <b>claim</b> . <b>We</b> may appoint <b>your</b> own solicitor but on a similar-fee basis as <b>our</b> solicitor and only for work done with <b>our</b> prior written approval.
Partially covered claims	<p>If a <b>claim</b> which is only partially covered is made against <b>you</b>, <b>we</b> have the right and duty to defend <b>you</b>, but amounts relating to non-covered parts of <b>claims</b> will be deducted from <b>our</b> final settlement. However, for <b>claims</b> or parts of <b>claims</b> which allege or arise from any infringement, use or disclosure of a patent, or any use, disclosure or misappropriation of a trade secret, <b>we</b> and <b>you</b> agree to allocate all amounts, including <b>defence costs</b>, upon <b>our</b> receipt of the <b>claim</b> or <b>potential claim</b>.</p> <p><b>We</b> and <b>you</b> agree to use best efforts to determine a fair allocation of covered and non covered parts of <b>claims</b>. If <b>you</b> and <b>we</b> cannot agree on a fair allocation <b>you</b> and <b>we</b> agree to follow the dispute resolution process in the General terms and conditions of this <b>policy</b>.</p> <p>If a covered or partially covered <b>claim</b> is made against <b>you</b>, then <b>we</b> have the right to appoint suitably qualified legal representation to defend <b>you</b>.</p> <p><b>We</b> have no duty to defend <b>you</b> against <b>claims</b> where:</p> <ol style="list-style-type: none"><li>1. no part of the <b>claim</b> is covered; or</li><li>2. <b>we</b> pay <b>you</b> the limit of indemnity as described in <b>How much we will pay</b>, Paying out the limit of indemnity or if the overall limit of indemnity stated in the schedule has been exhausted.</li></ol>
Payment of excess	<b>Our</b> duty to make any payment under this section arises only after the applicable <b>excess</b> is fully paid. The <b>excess</b> will only be eroded by the covered parts of a <b>claim</b> .
